

THE UA MAP INVESTMENT PROJECT TEMPLATE

THE OBJECTIVE

- A consistent format for presentation of Ukrainian EE and RE investment opportunities that balances the needs of investors and project promoters.
- Standard structure including information needed by most external investors for initial assessment.
- Easy identification of relevant opportunities based on selection of technology, size, etc.
- Easy screening of project basics, including stage of development, available approvals.
- Indication of financial feasibility through promoter's assessment of expected investment,
 revenues and financial return.
- Possibility to link to supplementary presentations, feasibility studies, etc.

Overview of financing sources for EE and RE in Ukraine






KEY TYPES OF ACTORS

- Private Investment Funds
